RESOLUTION 30-2026

AN ORDINANCE TO REAUTHORIZE THE SUBMISSION OF AN APPLICATION TO THE OHIO PUBLIC WORKS COMMISSION FOR AN INFRASTRUCTURE GRANT TO REPAVE ROWE ROAD, AND OTHER STREETS AND ALLEYS WITHIN THE VILLAGE AND DECLARING AN EMERGENCY

WHEREAS, the Village of Lockbourne, Ohio maintains roads, streets and alleys within the Village municipal boundaries; and

WHEREAS, the Village seeks to repave and improve the roads, streets and alleys within the Village municipal boundaries; and

WHEREAS, the Village Council previously passed Resolution 23-2025 to authorize this submission, however such ordinance was not certified for publication; and

WHEREAS, this ordinance is necessary to meet compliance of the OPWC program.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF LOCKBOURNE, OHIO:

Section 1: The Village Council hereby re-authorizes the Mayor and/or her designee to apply for the Ohio Public Works Commission Grant for the improvement of Rowe Road, streets and alley ways within the Village.

Section 2: This council finds and determines that all formal actions of this Council concerning and relating to the adoption of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

Section 3: That this Ordinance is hereby declared to be an emergency measure, the emergency being the necessity to comply with OPWC grant terms and to be eligible for award. Therefore, this Ordinance shall be in full force and effect immediately upon its passage.

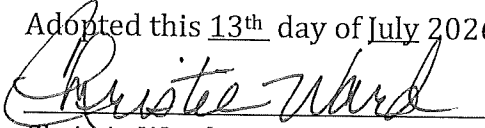

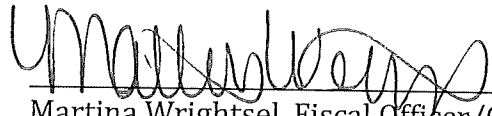

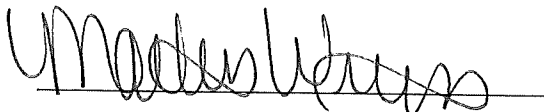
