RESOLUTION 31-2026

AN RESOLUTION TO ADOPT THE TAX BUDGET FOR THE VILLAGE OF LOCKBOURNE, OHIO FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2027, AND TO SUBMIT THE SAME TO THE FRANKLIN COUNTY BUDGET COMMISSION AND DECLARING AN EMERGENCY

WHEREAS, the 2026 Tax Budget has been prepared as required by Section 5705.28 of the Ohio Revised Code; and

WHEREAS, the Ohio Revised Code requires that the Tax Budget be adopted by July 15th and transmitted to the Franklin County Budget Commission on or before July 20th; and

WHEREAS, a public hearing was held on July 13th prior to the regularly scheduled Council meeting.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF LOCKBOURNE, OHIO, THAT:

Section 1. The Tax Budget for the Village of Lockbourne, Ohio for the fiscal year beginning January 1, 2027, is hereby adopted by the Council of the Village of Lockbourne, Ohio.

Section 2. The Fiscal Officer be and hereby is authorized and directed to certify a copy of said budget and a copy of this Ordinance and to transmit the same to the Franklin County Budget Commission on or before July 20th.

Section 3. This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, welfare, and safety and for the further reason that there exists the immediate necessity to certify a copy of the Tax Budget to the Franklin County Commissioners before July 20th; WHEREFORE, this Ordinance shall take effect and be in force from and after its passage.

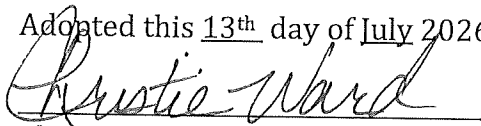

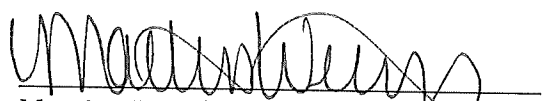

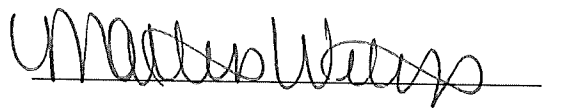
