Resolution 33-2026

A RESOLUTION AUTHORIZING A PERMANENT TRANSFER OF FUNDS FROM THE GENERAL FUND CAPITAL OUTLAY ACCOUNT (1000-310-590) TO THE GENERAL FUND HEATING OIL ACCOUNT (1000-310-314), AMENDING APPROPRIATIONS ACCORDINGLY, AND DECLARING AN EMERGENCY

WHEREAS, the Village of Lockbourne is responsible for maintaining Village-owned properties and buildings; and

WHEREAS, the Historical Hall is heated by propane gas, and adequate funding is necessary to ensure continued heat for the facility; and

WHEREAS, Council finds it necessary to increase the budget authority for the General Fund Heating Oil Account to provide sufficient funds for heating the Historical Hall through the end of the year;

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Lockbourne, State of Ohio:

SECTION 1. The Fiscal Officer is hereby authorized and directed to make a permanent transfer of funds in the amount of **\$5,000** from the **General Fund Capital Outlay Account (1000-310-590)** to the **General Fund Heating Oil Account (1000-310-314)**.

SECTION 2. The annual appropriation for the **General Fund Heating Oil Account (1000-310-314)** is hereby increased by **\$5,000** to provide the necessary budget authority for the payment and proper recording of heating-related expenses.

SECTION 3. The Fiscal Officer is hereby authorized and directed to make all necessary entries in the UAN system and Village financial records to reflect the transfer and appropriation increase authorized by this Resolution.

SECTION 4. It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were taken in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in such formal action were conducted in meetings open to the public in compliance with all applicable legal requirements.

SECTION 5. (EMERGENCY CLAUSE) This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the inhabitants of the Village of Lockbourne, and for the further reason that it is immediately necessary to ensure sufficient funding for propane gas needed to heat the Historical Hall. Therefore, this Resolution shall take effect and be in force immediately upon its passage.
