ORDINANCE 35-2026

AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR TO ENTER INTO A CONTRACT FOR SOLID WASTE COLLECTION, CURBSIDE RECYCLING, AND YARD WASTE SERVICES THROUGH SWACO CONSORTIUM III FOR A FIVE-YEAR PERIOD COMMENCING IN 2027 AND ENDING IN 2031, AND DECLARING AN EMERGENCY

WHEREAS, the Village of Lockbourne, Ohio, currently receives necessary weekly solid waste collection, curbside recycling, and yard waste services pursuant to an existing contract that is scheduled to expire on December 31, 2026;

WHEREAS, Council has determined that it is in the best interest of the Village and its residents to continue providing trash collection services to all households, with charges to be billed to residents on a quarterly basis by Local Waste Services, and with a ten percent (10%) discount to be applied for qualifying head-of-household residents who are sixty (60) years of age or older;

WHEREAS, in order to preserve the public health, safety, cleanliness, and welfare of the Village, trash collection services shall continue for all residents notwithstanding delinquency in payment; and any customer whose account remains unpaid thirty (30) days after billing shall receive a written reminder of the past-due balance, and Local Waste Services may assess any applicable fee for the issuance of such notice; and if any amount remains unpaid sixty (60) days after the original bill date, the customer shall be notified by certified mail and given fourteen (14) days to remit payment in full; and if payment is not received within such fourteen-day period, the Village of Lockbourne shall be responsible for payment of the resident's collection debt in order to maintain continued collection services, whereupon a convenience fee of one hundred dollars (\$100.00), together with the original unpaid amount assessed to the Village, shall be assessed to the homeowner and placed upon the homeowner's real property taxes as permitted by law;

WHEREAS, the Village desires to participate in and extend services through SWACO Consortium III upon the terms, conditions, and pricing offered for the applicable contract period.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF LOCKBOURNE, OHIO:

Section 1: The Village Administrator is hereby authorized and directed to enter into and execute, on behalf of the Village of Lockbourne, all necessary agreements and related documents for participation in SWACO Consortium III for solid waste collection, curbside recycling, and yard waste services, upon such terms and conditions as are offered and approved.

Section 2: It is hereby found and determined that all formal actions of Council concerning and relating to the adoption of this Ordinance were taken in an open meeting of Council, and that all deliberations of Council and of any committees or decision-making bodies of the Village of Lockbourne that resulted in such formal actions were conducted in meetings open to the public and in compliance with all applicable legal requirements.

Section 3: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the Village, the emergency being the need to timely initiate and complete the agreement process with SWACO Consortium III and Local Waste Services in preparation for continued uninterrupted waste collection services. Accordingly, this Ordinance shall take effect and be in full force immediately upon its passage and approval by the Mayor, or at the earliest time permitted by law.
