RESOLUTION 36-2026

A RESOLUTION AUTHORIZING SUBMISSION OF AN APPLICATION FOR THE OHIO PUBLIC WORKS COMMISSION INFRASTRUCTURE GRANT FOR REPAVING OF ROWE ROAD, STREETS AND ALLEYS WITHIN THE VILLAGE AND DECLARING AN EMERGENCY

WHEREAS, the Village of Lockbourne, Ohio maintains roads, streets and alleys within the Village municipal boundaries; and

WHEREAS, the Village seeks to repave and improve the roads, streets and alleys within the Village municipal boundaries; and

WHEREAS, it is beneficial to the citizens of the Village of Lockbourne that the roads, streets and alleys were improved; and

WHEREAS, the Village had decided to apply for grant funding through the Ohio Public Works Commission for the improvement and repaving of roads, streets and alleys.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF LOCKBOURNE, OHIO:

Section 1: The Village Council hereby authorizes the Mayor and/or her designee to apply for the Ohio Public Works Commission Grant for the improvement of Rowe Road, streets and alley ways within the Village.

Section 2: This council finds and determines that all formal actions of this Council concerning and relating to the adoption of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council and any of its committees that resulted in those formal actions were in meetings open to the public in compliance with the law.

Section 3: This Resolution is hereby declared to be an emergency measure, the emergency being the necessity to submit the application before the deadline. Therefore, this Resolution shall be in full force and effect immediately upon its passage.
